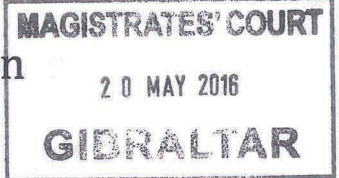


# Regina v Philip Arundel van der Westhuizen



3<sup>rd</sup> Written Statement of Philip Arundel van der Westhuizen.

With reference to the clerk of the court's summation at the beginning of the 11/5/2016 hearing:

It's impossible to have been found "guilty", which I did not comprehend before; not understanding the (deceitful) legalese, because:

1. There is no lawful judge or court, only men fraudulently impersonating judges, and representing an evil woman who is fraudulently pretending to be a queen:
2. As previously stated, **absolutely ALL** of the legal system's mechanisms and devices, proceedings and conclusions contravene Deuteronomy 4:2 and are thereby NULL AND VOID; *ultra vires* (deceitful legalese); absolutely without power and authority:

King of kings' Bible by JAH [JAHTruth.net.net/kofkad](http://JAHTruth.net.net/kofkad) Deuteronomy (5th Book of The Laws of God) 4:2 **Ye shall not ADD unto the word** which I command you, **neither shall ye diminish [ought] from it**, that ye may keep the **Commandments** of the "I AM" your God which I **COMMAND** you.

3. But furthermore the judicial oath, while paying lip service to "do right to all manner of people", calls upon God for assistance to "well and truly serve" Mrs. Elizabeth Battenberg / Mountbatten, instead of serving Him, which directly contradicts His **Command**:

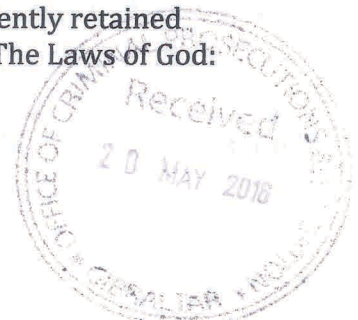
Judicial oath: "I, ... , do swear [*or solemnly affirm*] that I will **well and truly serve** Our Sovereign Lady Queen Elizabeth II, Her Heirs and Successors, in the office of Chief Justice/Puisne Judge/President of the Court of Appeal/Justice of Appeal of the City of Gibraltar and will **do right to all manner of people** after the laws\* and usages of the City of Gibraltar without fear or favour, affection or ill will. King of kings' Bible by JAH [JAHTruth.net.net/kofkad](http://JAHTruth.net.net/kofkad) Mark (Jesus quoting The Law) 12:30 **And thou shalt** love the Lord thy God with all thy heart, and with all thy soul, and with all thy mind, and with all thy strength and **serve Him ONLY**: this [is] the first **COMMANDment**.

Which renders the judicial oath NULL AND VOID, and fraud, and **all** pronouncements in terms thereof NULL AND VOID. The judge's oath being null and void means there is no judge, only a man impersonating a judge, for which he/they should be arrested.

4. And the BAR (British Accreditation Register) oath **solely** pledges allegiance to Mrs. Elizabeth Battenberg / Mountbatten also contravening That 1<sup>st</sup> Commandment, also rendering it NULL AND VOID.
5. Furthermore, Mrs. Elizabeth Battenberg / Mountbatten has, in Gibraltar's Constitution under the section "Power of Her Majesty" (Clause 8 of Annex 2), fraudulently retained the right to continue breaking Deuteronomy 4:2; to **indefinitely** break The Laws of God:

6. King of kings' Bible by JAH [JAHTruth.net/kofkad](http://JAHTruth.net/kofkad)  
Psalms 2:10 Be wise now therefore, O ye kings: **be instructed, ye judges** of the earth.  
2:11 Serve the "I AM" with fear, and rejoice with trembling.

7. This is an example of **ambiguous** legalese in the constitution: Clause 83 "Saving for jurisdiction of courts". It's unintelligible.

"No provision of this Constitution that any person or authority shall not be subject to the direction or control of any other person or authority in the exercise of any functions under this Constitution shall be construed as precluding a court of law from exercising jurisdiction in relation to any question whether that person or authority has performed those functions in accordance with this Constitution or any other law or should not perform those functions." Which is one of the reasons why Deuteronomy 4:2 absolutely **forbids** adding to The Law.

8. But the whole Constitution, by its presence contravenes Deuteronomy 4:2, and its contents in several instances blatantly reverses several of God's Laws (See examples in the 1<sup>st</sup> Written Statement 21/12/2015 Appendix 1 or [Jforjustice.net](http://Jforjustice.net) "Challenge").

9. So it's worth repeating again - from the Coronation Oath:

"I will to the **utmost of my power** maintain The Laws of God."

"The things which I have here before **promised I will perform and keep.**"

"So help me God."
